SCHEDULE-TERMS AND CONDITIONS FOR LICENCE OF RETAIL/BAZAAR STALL

(All references to "us" or "we" refer to the Chinatown Business Association and all references to "you" refer to the Licensee stated in the Licence Agreement)

1. You agree to remove and change any displays, activities, structures within the time specified by us, should there be any complaints received by us and undertake to comply with any of our instructions immediately. If you fail to remove or change displays, activities, structures within the time specified by us, we shall have the right to remove or change any such displays, activities, structures without further reference to you and such removed items shall be returned to you after the expiry of the licence. We shall not be responsible for any loss or damage of the goods/items in the course of such removal or storage elsewhere.
2. You shall be solely responsible and shall indemnify and keep us indemnified against all claims for losses, damages, injury, death or otherwise arising out of any occurrences in the licence of the Retail Space.
3. You shall not sell, display, keep at the Retail Space, use or allow the use of any illegal, unlicensed, counterfeit or fake goods nor use the same for any illegal or unlawful purposes or activities. You shall be solely liable and responsible and indemnify and keep us fully indemnified against any action or prosecution in respect of such goods, purposes and activities.
4. You are to ensure that the Retail Space and every part thereof are kept clean at all times and refuse or rubbish is collected and removed and deposited by such routes and in such areas as we may direct.
5. All advertisements, notices, flyers and other promotional material must be approved by us in writing before publication or distribution.
6. You shall be responsible for dealing with any complaints from dissatisfied customers and participants, including where necessary, offering suitable replacements and indemnifying and keeping us free of all claims in respect of your goods and services.
7. You shall ensure that you are suitably insured against any liability or claims from any party in respect of your goods and services.
8. You are not to tout, harass, solicit or to do anything which may be or become a nuisance, annoyance, disturbance or inconvenience to the shoppers, owners, tenants and occupiers of the Bazaar.
9. You are to ensure that the passageways around the Retail Space or Bazaar tentage are not obstructed and are kept clear for the smooth flow of shoppers and all display must be kept within the permissible area.
10. You will not hold us liable or responsible for any losses or damage suffered by you due to any interruption to any of the services, facilities or utilities supplied by us to you for any reason whatsoever and whether beyond our control or not.
11. You shall be fully responsible for the storage of merchandise. No merchandise is to be left on the floor and/or cause obstruction to shoppers.
12. At the close of business at the end of the day, you are required to remove and secure all merchandise and any other items. We shall not be responsible for any loss or damage of items/merchandise.
13. No subletting, partly or fully is allowed.
14. You are advised to take the appropriate and necessary insurance coverage.
15. We shall not be held responsible for any damage, loss or theft of the goods/products displayed.
16. You are to return the Retail Space with Bazaar Tentage, Tables, Stools and Power Supply Point to us in good and rentable condition upon termination of the licence.
17. We reserve the right to allocate other available spaces in and around the Retail/Bazaar Space for other exhibition(s) or promotion(s) or any other use during the duration of the licence.
18. Notwithstanding anything contained herein, we reserve the right to terminate the licence at any time, whether before or during the licence period, by giving you 24 hours' written notice in the event of a breach by you of any terms and conditions herein. In such event, all licence, administrative fees and other monies paid by you shall be wholly forfeited by us, without prejudice to any other rights that we may have in respect of such breach or any other breach of the terms and conditions herein.
19. The organizer shall not be liable to the Licensee in the event of any cancellation, shortening of opening days and / or hours of the exhibition, for any non-performance of their obligations under this contract or for any amendments or alteration to all or any of the rules and regulations of the event if such occurrence is due to any circumstance not within their control.
